## **RULES AND RESTRICTIONS**

- NO HAZARDOUS WASTE, LIQUIDS, OR CHEMICALS OF ANY KIND ARE ALLOWED INSIDE CONTAINER.
- BIN IS SUBJECT TO RANDOM INSPECTION.
- DO NOT LOAD BIN ABOVE THE TOP RIM AS IT WILL NEED TO BE COVERED DURING TRANSPORT.
- THERE IS A MAXIMUM RENTAL OF 10 DAYS. SPECIAL ARRANGEMENTS MAY BE MADE IF MORE TIME IS NEEDED.
- MAXIMUM CAPACITY FOR ALL SIZES = 10 TONS (20,000 LBS.)

Permission is hereby given to Red Rock Environmental Group to furnish containers and supply rubbish disposal service to customer. Customer shall be responsible for any and all damages arising out of misuse of container; such as overloading or improper loading. Also, customer shall be responsible for charges incurred for stand-by time or a trip fee for empty or overloaded containers not picked up. Customer expressly assumes all risk of injury and/or damage in the use, operation, and/or possession of the container and/or equipment provided pursuant to the terms of this agreement. Further, customer expressly agrees to defend, indemnify, and hold Red Rock Environmental Group harmless from and against all claims, liability, loss damage, and expenses, including reasonable professional fees, awards, fines, or judgement arising from, in connection with, or by reason of the death or bodily injury to persons, injury to property, either real or personal, or other loss, damage or expense, including any of the same resulting from any alleged or actual negligent act or omission of act, regardless of whether such act or omission is active or passive, resulting from or arising in any manner out of the customer's use, operation or possession of the container and/or other equipment provided or furnished under this contract. In the event any legal proceeding is necessary or instituted on this agreement, the prevailing party shall be entitled to recover its reasonable attorney's fees and costs unless parties agree to arbitration. Customer acknowledges and specifically agrees that Red Rock Environmental Group shall have absolutely no liability whatsoever for any damage to property or pavement. Customer understands that Garbage Service Vehicles create a significant chance of cracking, breaking and/or damaging concrete, asphalt and/or brick. Customer understands that Garbage Service Vehicles weigh over 30,000 pounds and can create immediate and/or long term damage to roadways. Under no circumstances shall the container be used for hazardous or toxic waste disposal, as defined in the California health and safety code, nor be used for hard-to-handle material, unless prior arrangements have been made with Red Rock Environmental Group.
